### 1. Streamlined Sustainability Management

- The 1st step in the partnership is under way. This consists of replacing a number of sophisticated Excel spreadsheets used to monitor and measure Sustainability across a large number of topics with a consolidated view on the Ascentys platform.
- Starting with the "Carbon Footprint" module, ten23 will then leverage the "People" module to manage JEDI (Justice, Equity, Diversity and Inclusion) topics as well as the "Sustainability" module of the Ascentys Sustainability platform to manage their overall performance across 360 Environmental, Social and Governance Indicators.
- The outcome will be an easy-to-manage platform that consolidates and centralises ten23 data, making it more formalized, robust and scalable.

## 2. Better oversight of Actions and changes

 Once ten23 has transitioned from XLS to managing its Sustainability in the Ascentys platform, the next step will be to use the system to better manage the progress of actions and objectives. ten23 will be able to track its actions directly in the platform, increasing visibility into activities across the organization and stakeholders.

- A critical aspect on ten23 roadmap is to leverage data to drive informed, transparent (reasoned and justified) decision making and prioritisation of Sustainability related initiatives.
